

2024 has been a fruitful year for Singapore's Centre for Liveable Cities (CLC).

I am happy to share that the 9th edition of our flagship event, the World Cities Summit (WCS), held in June this year, was a resounding success. About 3,500 delegates, including country and city leaders from close to 100 cities, convened in Singapore to participate in an expanded conference programme curated by CLC in close partnership with Singapore government agencies, international organisations like the UNDP and C40, and a range of industry players.

WCS this year saw the launch of a new global City Network for the Lee Kuan Yew World City Prize. This Network brings together city leaders, urban governance departments, and knowledge organisations to collectively address how our cities can be liveable, sustainable and resilient in the face of present and future urban challenges. The seven Laureate cities of the Lee Kuan Yew World City Prize have joined as founding members, and CLC is engaging Special Mention cities and nominated knowledge organisations to join the network as well. Additionally, we inked several Memoranda of Understanding (MoU) during the Summit, cementing future collaborations in research and capability development with cities, and other partners.

Cities around the world face common challenges – climate and environmental, socio-economic, and financial stresses, disruptions and constraints. CLC is in a unique position to motivate, facilitate, and draw inspiration from our counterpart cities in a continuing flow of knowledge exchanges.

CLC has continued to fulfil in our mandate to share knowledge, enable peer learning and expedite solutioning with stakeholders and partners via:

Research initiatives and collaborations

A good number of research publications have come to fruition. The Liveability Framework has been relaunched with a more comprehensive understanding of how to liveability outcomes for cities since its first edition a decade ago. Two other publications on regenerative cities and the future of Central Business Districts (CBDs) were the result of collaborative studies between CLC and notable industry partners Ramboll and Arup. Beyond publications, CLC's research team organised a slew of research initiatives, such as the Social Behavioural Science Community of Practice (COP), and roundtable discussions with the Seoul Institute and National Development and Reform Commission (China).

Capacity development

CLC continued to run our signature training programmes, developing future-ready capabilities in urban governance for global cities and for our own public sector leaders. CLC is honoured to have hosted senior officials from China, Indonesia, North Macedonia, Uganda, Tanzania, and Pacific Island Forum states. The latter participated in the inaugural Singapore-Pacific Resilience and Knowledge Sharing Package held just a week before WCS 2024. Locally, we celebrated the 100th run of the City EXCEL programme which has benefitted over 2,700 participants in the Singapore public service.

Finally, I am pleased to share CLC's participation in the global conversation on cities in 2024. In October, the CLC-led Dementia Friendly Neighbourhood Project received the Horizon Shaper Award at the inaugural Bay Awards in Bilbao. This project was shortlisted from over 100 international potentials across five continents. Last month, CLC curated the Cities Thematic Day under the Singapore Pavilion, at COP29 in Baku, Azerbaijan. Stakeholders from across sectors and cities came together across three panels to discuss key topics to strengthen multi-level climate action and build liveable cities of the future. CLC was also represented at the World Urban Forum hosted by Cairo, and the U20 summit hosted by Rio De Janeiro.

My colleagues at CLC and I would like to express our heartfelt appreciation to all our partners who have worked closely with us throughout the year to deliver quality programmes and meaningful research projects for the benefit of our cities and communities.
